 - E. Utilize and apply the Diagnostic Statistical Manual V to substance use disorders and understand the differences of diagnosing for psychiatric disorders.
 - F. Analyze the family roles and dynamics when working with a person with co-occurring disorders.
 - G. Analyze the professional ethics in the field of co-occurring disorders, including professional boundaries, dual relationships, counter-transference and co-dependency.

A final, a midterm, quizzes, writing exercises, and observation and evaluation of case studies of co-occurring disorders.

For example:

- 1. A written report of student and instructor observations of case vignettes on the common characteristics and treatment modalities of co-occurring disorders.
- 2. A multiple choice or short answer quiz of reading of a chapter on Professional ethics from the textbook and supplemental readings. Students will prepare for the quiz by working in small groups to review the assigned chapter and develop a study guide with the main points of the chapter.

- **6. Assignments:** State the general types of assignments for this course under the following categories and provide at least two specific examples for each section.
 - A. Reading Assignments

Selected readings from the textbook, periodicals or the library collection covering theory and applications working with co-occurring disorders.

For Example:

- 1. Read a chapter from the book on theories of co-occurring disorders. In small groups, discuss the strengths of each theory. Develop a chart for studying the various theories, outlining their strengths, applications, typical symptoms observed by each theory.
- 2. Read the chapter on diversity issues when working with co-occurring disorders. Define the cultural and ethnic differences when working with these disorders. Identify

other differences observed when working with people from different age or gender backgrounds.

B. Writing Assignments

Written essays, papers and journal entries on issues related to co-occurring disorders in substance use.

For example:

- 1. Research and write a 5-page paper on how a specific cognitive or physical limitation (such as ADHD) affects a person addicted to drugs or alcohol. Define the physical or cognitive limitation with supporting research, and provide examples of symptoms and behaviors observed in clients with these limitations and/or special abilities. Describe the treatment steps needed to address these co-occurring disorders.
- 2. In a short essay, write the common treatment strategies for persons with mood disorders who also struggle with an addiction. What professionals would you need to work with or refer to in order to develop an effective treatment plan?
- C. Other Assignments

Journal writing and practice of techniques through case studies and vignettes.

Examples:

- 1. Utilizing journals, students will reflect in writing on the vignettes and case studies discussed in class or observed through DVD presentations. The instructor will give written prompts, such as, ?What were the most common symptoms observed in the client?"
- 2. Practicing the techniques of resolving ethical issues in the workplace, students will practice a case scenario of a violation of the code of ethics regarding dual relationships.
